Ms Jade Frieser, Sustainable Partnerships Australia

Jade Frieser is a youth engagement project officer whose career path began through a youth work student placement at Sunshine Coast Sustainable Partnerships. Jade continued to volunteer in the Youth Engage Action Crew and has progressed into project and administration roles. Jade is also a musician and performer and was involved with the Sunshine Coast Youth Summit and R U Serious projects.

The annual Sunshine Coast Partnership Youth Summit conducted by Sustainable Partnerships Australia, brings young people together to address key issues that have been identified through a pre-Summit survey. The Drink Safe Raw Sounds project and the R U Serious campaign are examples of such initiatives. The first is a strategy aimed at addressing the issues of binge and the second to assist youths struggling to tap into the job market. The Summit participants' identify relevant solutions to their issues which are then shared with the wider community.



Paul Moreton, Chief Executive Officer, IFYS Ltd

Paul is the CEO of IFYS Ltd, a Queensland based human services organisation. IFYS provide specialist support and intervention programs for children, young people and families. They work closely with other non-government and government agencies and operate from locations throughout Queensland, ranging from Toowoomba in the west through to Cairns in the far north of the State. IFYS provides food programs, accommodation, support, disability, child protection and social inclusion services. They see up close the issues effecting youths and families.

Paul has spent the past 28 years working with marginalised people as a Counsellor, Educator and Community Development Worker among other roles. His experience has included researching and communicating on social issues and effectively targeting, on behalf of Federal, State and corporate clients, hard to reach groups including those involved in the subversive sex industry and drug users who experience difficulty in accessing mainstream sources of information.



Kylee Bates, State Director (Vic/SA), Mission Australia.

Kylee joined Mission Australia in September 2008 and held the roles of National Program Manager, Employment Solutions and more recently the General Manager Employment Solutions across Victoria, Tasmania, South Australia and Western Australia.

Prior to joining Mission Australia Kylee worked for the Department of Prime Minister and Cabinet on Indigenous policy, and held various policy and program roles with the Department of Families, Housing, Community Services and Indigenous Affairs. This included a period as Departmental Liaison Office to the Minister for Families and Community Services, the Hon. Jocelyn Newman.

Kylee was Deputy CEO of Volunteering Australia, the national peak body for volunteering between 2003 and 2007 and now serves as Vice President on the board of the International Association for Volunteer Effort.

In 2012 Kylee undertook a Churchill Fellowship and travelled to 6 countries to examine employer-led initiatives that are increasing the employment of people with disabilities.
