Dr Boyd will present a new way to categorise projects and portfolios of regional significance. The presentation addresses the research findings of the Sunshine Coast Business Council commissioned research into game-changing projects and how to realise the promised economic ripple effect.

The research uses a design approach to look again at how significant public and private projects are assessed and what approaches are followed to share the economic gains.

As part of the initial validation Dr Boyd will demonstrate the framework's application to a suite of 'game-changing' projects on the Sunshine Coast. This evaluation considers the categorisation, measurement and delivery of proposed infrastructure projects such as light rail and the developing North Coast Connect initiative.
